

SmartOnes[®]

Use WeedOut[®], a selective herbicide for spot treatment control of weeds in lawns:

Dandelion*, Ragweed, Ground Ivy (creeping Charlie), White Clover, and Poison Ivy**. Controls many broadleaf weeds in residential land, along driveways, and walkways. Post-emergent foliar treatment rapidly desiccates the target weed. When applied according to label directions, it travels through the foliage, stems and root system. Visible signs of control may be seen within 24 hours after application due to rapid loss of water from plant cells. Only vegetation that is contacted will be controlled.

DIRECTIONS FOR USE: SHAKE WELL BEFORE USING.

No dilution or mixing needed – just load and spray!

- Remove protective cap and retain for storage of unused product.
- To activate, set locking dial to ON. Set to OFF when not in use.
- Insert cartridge upside down in the cone of the SmartOnes[™] Precision Sprayer.
- Lock handle firmly in place.
- Place the SmartOnes[™] Precision Sprayer over the weed to be treated.
- Gently push handle down to release the product. Spray covers an area 8.9 cm (3.5 inches) in diameter.

Best results are obtained when applied prior to flowering and while plants are still small. Ensure complete coverage. Wet only unwanted foliage. Smaller plants are less likely to experience re-growth. Some mature weeds may require a second application.

***Dandelion Control:** For root kill, ensure solution accumulates in the centre of the crown as well as covering the leaves. For lawns, apply shortly after mowing for best results. A second application may be needed for older or large dandelions.

****Poison Ivy Control:** For root kill, repeat applications (3 to 4 weeks apart) may be needed to control poison ivy. Repeat application may be needed the following year. Optimum Application Conditions: Apply under sunny conditions when ambient temperature is at least 24°C. Some re-growth may occur if applied under cloudy or shady conditions, or when temperature is below 24°C. Do not apply when rain is forecast within the next few hours. Avoid use in sunny conditions when temperature exceeds 31°C or when winds are gusty. Foliage that is accidentally sprayed may be affected. Some other species including grasses and broadleaved plants may be affected. Do not apply on or near desirable plants such as vegetables or ornamental plants. If desired plants are contacted, rinse them off immediately with water. **PRECAUTIONS:** May cause eye and skin irritation. Avoid contact with skin, eyes and clothing. Avoid ingestion and inhalation. Wash hands after handling and before meals.

- **READY TO USE - FAST ACTING**

Control undesirable plants in lawns, in and around the garden, on patios, sidewalks, driveways, along fences and around established trees and shrubs. Use to control weeds in lawns, sidewalks, driveways, patios, gravel and mulch.

Complete coverage is necessary for best results. Wet only unwanted foliage. Re-apply for large weeds and re-growth of perennial weeds, if required. Weeds that are mature, dormant or hardened due to moisture stress tend to be more tolerant to herbicide treatments. When using to control top growth of dandelions and plantain in lawns, grass that is accidentally contacted will also be burnt but re-growth will occur.
